WAIVES AND RELEASES ANY CLAIMS, INCLUDING THOSE OF NEGLIGENCE OR EQUIVALENT CONDUCT WHICH I MAY HAVE AGAINST THE FORT WALTON YACHT CLUB AND FLEET 77, AND THEIR OFFICERS AND MEMBERS RESULTING FROM MY PARTICIPATION IN THE 2011 NORTHERN GULF COAST CRUISE ("EVENT": HEREAFTER) AND ALL ACTIONS RELATED TO.

Acknowledges my responsibilities in participating in this event, for my decisions to start or continue in this event and to make certain that my boat, equipment and crew are seaworthy for the conditions, which may be encountered during my participation.

Acknowledges that maritime tradition and law provide that a vessel's Captain is ultimately and solely responsible for the welfare of ship and crew and must possess the competencies of prudent seamanship and independent action necessary to provide for the same. By registering to participate in this event I attest that I possess these competencies and agree to fully accept the accompanying responsibilities.

Specifically waives any statute, by incorporating its reference and citation herein, which may require such inclusion and reference in order to effect these provisions.

If any provision of the agreement is not enforceable, such determination shall not affect the enforceability of the remaining provisions of this agreement.
